- b. You will be entitled for the mobilization advance @ 20% (twenty percent) of the Contract Price on fulfilment of contract conditions.
- d. Following facilities without any cost effect shall be provided to: -

- (b) Telephone/Electricity/Water charges for the site office.
- (c) 2xToyota Cars, with maint cost for 2 years.
- (d) Provision of Residence for Staff and Officer and Provision of Main Office for NLC. Both these facilities to the extent of Rs. 5 Million only for the entire duration of the project. Any amount which goes beyond Rs. 5 Million will be borne by NLC.

- (a) Site Office duly furnished.
- (b) Telephone/Electricity/Water charges for site office.
- (c) 1x Double Cabin with maint cost of 2 years. (as reflected in

5. Please prepare the Contract Agreement on Judicial Paper, as per sample form of agreement enclosed for signature, within (14) fourteen days of the receipt of form of agreement.
6. You shall maintain possession after taking over of site.
7. Please sign, affix stamp and return a copy of this Letter of Acceptance in token of acceptance. This letter, duly accepted by you, shall form a part of the Contract.
